<u>Order</u>

1. Mr. Manoj Bhandari, learned counsel submits that the letter dated 25.06.2021, issued by the Reserve Bank of India, interferes with the service conditions of the Managing Director / the Chief Executive Officer, who are governed by the bye laws and rules framed under the Cooperative Societies Act.



- 2. Learned counsel further submits that the Urban Cooperative Bank has been registered under the provisions of the Rajasthan Cooperative Societies Act and recruitment, terms and conditions of service of its employees fall under Entry 32 in List-II-State List of the Seventh Schedule of the Constitution of India, whereas "Banking" comes under Entry 45 in List-I of the Seventh Schedule.
- Thus, the power to legislate in the filed of cooperative societies vests with the State Government and does not fall within the domain of Central Government, much less Reserve Bank of India. He thus argues that the Reserve Bank of India has no power or competence to issue impugned communication/letter dated 25.06.2021.
- 3. Matter requires consideration.
- 4. Issue notice. Issue notice of stay application also, returnable within six weeks.
- 5. Meanwhile, no action shall be taken against the petitioner pursuant to clause (4) of the communication dated 25.06.2021, issued by the Reserve Bank of India.
- 6. Connect with S.B. Civil Writ Petition No.11222/2021.
